

Thailand Country-Specific Privacy Policy Terms:

If you are located in Thailand, in addition to your agreement with the foregoing Privacy Policy, you acknowledge and agree to the following provisions with respect to your use of this Site:

The provisions of the last paragraph in the above sections entitled “WHAT TYPES OF INFORMATION DOES THIS POLICY COVER?” and “WHO WILL HAVE ACCESS TO PERSONAL INFORMATION?” shall be deleted and replaced by the following wording:

CONSENT IN RELATION TO PERSONAL DATA

I consent to the personal data that I have provided or will provide as part of my job application process to be collected, used and disclosed by or on behalf of Citibank, N.A., Bangkok Branch or such other branch, subsidiary, representative office, affiliate or agent of Citibank, N.A. or a Citigroup entity (collectively “Citi”): (i) to manage my job application and to determine or investigate my suitability, eligibility or qualifications for employment with Citi, (ii) for Citi’s global recruitment functions and for related management, training and planning purposes, (iii) to communicate with me, (iv) to comply with applicable law or regulation, both domestic and foreign (v) to manage the relationship between me and Citi, (vi) to monitor and record services whether provided by a Citi entity or a third party (such as a recruitment firm), (vii) for crime and fraud detection, prevention, investigation and prosecution; (viii) to enforce or defend the rights of Citi, Citi customers and its other Staff, contractual or otherwise; and (ix) to make disclosures as permitted or required by applicable law such as in connection with investigations and to assist law enforcement and government authorities in Thailand or elsewhere.

For the purposes described above, and to verify or obtain an independent source for any information provided, Citi may collect, use and disclose, from or to any third party (including any background screening agency, service providers or credit bureau) or from any publicly available sources, additional personal data relating to me. I (a) expressly permit Citi and its representatives to share this notice with third parties; and (b) hereby authorise all such persons to disclose to Citi any of my personal data reasonably requested by Citi for one or more of the specific purposes as described above.

In the course of my job application, I may also be requested to provide personal data of other individuals (such as my relatives, dependents and other related parties). Such personal data are required for the purposes of determining my suitability for employment with Citi and also to enable Citi to comply with its legal and regulatory obligations and with Citi’s policies and procedures relating to hiring and employment. I warrant that in respect of the personal data of any other individual that I may furnish to Citi, (A) I am authorized to consent, and hereby consent on such individual’s behalf, to the collection, use and/or disclosure of his personal data as described above and/or (B) I have provided notice to, and have obtained consent from such persons to allow Citi to process their personal data as described above, prior to disclosure of such personal data to Citi.

All such personal data may be disclosed to another branch, subsidiary, representative office, affiliate or agent of Citi, and to third parties providing services to Citi, within and outside Thailand, for the purposes as described above. My personal data may be transferred to any person or entity to whom a Citi entity is under an obligation or otherwise required to make disclosure pursuant to legal process or under the requirements of any foreign or domestic law, regulation, court order or agreement entered into, binding on or applying to Citi, or agreement entered into by Citi and any government authority, domestic or foreign, or between or among any two or more domestic or foreign governmental authorities, or any disclosure under and for the purposes of any guidelines or guidance given or issued by any legal, regulatory, governmental, tax, law enforcement or other authorities, or self-regulatory of industry bodies or

associations of financial services providers or securities exchanges with which Citi is required or expected to comply, all of which may be within or outside Thailand.

I understand that if employment is offered and accepted by me, I may be required to provide additional consents to the collection, use and disclosure of my personal data.
